SEAC Report and Notes-Kenya/Andrea B:

- o Scott K talked about the alternative **Paths to Graduation** information that he presented to the State Board in Dec. 2020.
 - o Focus on Early Childhood Inclusion mentioned
 - Scott K's idea is similar to Indiana with adding a General Diploma option (18 credits but different blend towards strengths of student to age 25)
 - Postsecondary Readiness Requirement
 - Work Readiness Requirement

o New Special Education Program Flexibility-

- The MDE announced there will be new flexibility given to address teacher shortages in specific special education programs.
- Through the application of a waiver, districts can seek flexibility for the following programs for students with:
 - Cognitive Impairment
 - Emotional Impairment Specific Learning Disabilities
 - Speech & Language Impairment
 - Physical and Other Heath Impairment
 - Severe Multiple Impairment
- Approved waivers allow currently endorsed special education teachers whose endorsement may not match the program where a vacancy exists, to be used when appropriately endorsed teachers cannot be hired for these specific programs.
- Waivers for programs for students with Autism Spectrum Disorder are available under a separate waiver application process the department announced over a year ago.
- o This flexibility is available as a one-year renewable waiver.
