# SEAC Report- Notes from Andrea Beachnau and Kenya Harper

Dr. Scott Koenigsknecht, Michigan Department of Education (MDE) Deputy Superintendent, provided an update on the completed priority work of the SEAC for the school year 2021-22 and shared thoughts regarding the upcoming priority work of the SEAC for the 2022-23 school year. The Path Forward Strategic Action Plan Progress Updates were shared. He talked about what we should look forward too.

- On June 28, 2018, the United States Department of Education notified states of their federal determinations (IDEA), that Michigan was the only state to be determined "Needs Intervention". Michigan has been in the "Needs Assistance" Category from 2014-2017.
- This plan is not about making minor adjustments to the system to increase our reporting data and simply improve Michigan's federal determination status. This is an outcome-focused plan not to be admired but rather implemented to bring about transformative change to improve the entire system and support post-school success. The outcomes of this plan are not negotiable the educational community has an obligation to do whatever it takes to support learners and address opportunity gaps throughout the system.

# **Our Purpose**

A national workgroup assists in planning and facilitating national professional learning and capacity building activities to support states in organizing, orienting, and providing learning opportunities for SICCs and SAPs across the country.

- 4. Targeted Technical Assistance and Professional Development
- 5. Effective Dispute Resolution
- 6. Integrated Monitoring Activities
- 7. Improvement, Correction, Incentives, and Sanctions
- 8. Fiscal Management

### **Implementation of Policies and Procedures**

States must have policies, procedures and effective implementation of practices aligned with IDEA and State Statutes. These are to be implemented by local programs and must include descriptions of methods the state will use to detect non-compliance with IDEA and state laws as well as ensure correction of noncompliance. Program improvement that will improve outcomes for students with disabilities should be encouraged through improvement planning and incentives. Current interagency agreements and memoranda of understanding must be included explaining mechanisms for determining effectiveness of the agreements and MOUs.

## Conclusion

When the ICC and Panel have a better understanding of special education general supervision, they will be in a better position to provide advice to the Lead Agency and SEA.

# **Discussion**

Michigan Department of Education has submitted a Request for Rulemaking (RFR). In their review of MARSE requirements for homebound and hospitalized services and the State School Aid Act of 1979, the MDE's Office of Special Education has determined that there is a misalignment between the rule R 340.1746 and the state statute MCL 388.1709. Since the rule predates the statute, OSE is actively working on amendments to R 340.1746 to ensure alignment of the rule with the state law.
