# May SEAC Report (Submitted by Andrea Beachnau and Kenya Harper):

#### Legislative Update – Dr. Sheryl Kennedy

- Goal 8 Adequate & Equitable School Funding
  - Increases to all foundational funding (5% \$458 per pupil)
  - Senate (6% increase \$550 per pupil), House (4% increase \$366 per pupil)
- Goal 1 Early Childhood Opportunity Expansion
  - 5% increase GSRP
  - Eligibility federal poverty level to 300% and up to 400% in some circumstances
  - Senate increase 6% preschool and 250% federal poverty level
  - House increase 4% and expand eligibility 275% federal poverty level

  - Early Literacy Coaches increased funding

#### Intensifying Intervention Instruction – Dr. Melissa Nantais

- Revisited Data-based Individualization (DBI) from March SEAC
  - DBI is a systematic process for using data
  - DBI is an ongoing process not a single intervention
    - Universal screening data
    - Fidelity data
    - Progress Monitoring Data
    - Diagnostic Data
  - If Student Does Not Meet Expectations
    - Hypothesis 1 Did not receive adequate instruction (Fidelity)
      - Insufficient materials, bad location creating distraction, scheduling issues, low student engagement, missing data
    - Hypothesis 2 Instruction not sufficiently intense to meet needs
      - Is it group struggling or individual struggling, collect additional data, make a plan to intensify and document, progress monitoring
  - Taxonomy of Intervention Intensity 7 Dimensions
    - 1. Strength
    - 2. Behavioral Support
    - 3. Comprehensiveness
    - 4. Attention to Transfer (Generalization)
    - 5. Individualization
    - 6. Alignment
    - 7. Dosage
  - Start small and make one small change at a time

## Legislative updates:

Emily Henderson, Governmental Affairs Consultant and Lobbyist for Arc Michigan with McCall Hamilton, join us for this meeting and shared a legislative update.

Emily noted seeing a pause on legislative activity due to decisions being made about the current budget. School aid budgets came through with flags regarding the per pupil funding such as:

- Special education foundation allowances
- Offset funding to Intermediate Schools Districts (ISD) and libraries
- Mental health and school safety in excess of \$30 Million.
- Adult education
- Mental health school safety in excess of \$10 Million.
- School counselors' program
- Loan assistance of \$250.00 per month if constituents work in a high needs district.

The budget will be headed to the floor and then to committees to fine tune all the details. Emily noted that we are in a season of cuts and reminded members that the school aid fund is not general fund, therefore no cuts to school aid fund; however, may see a decrease in revenues due to partisan issues. On a positive note Emily state that we could see this wrapped up between a month or month and a half. Emily also told members that per pupil funding went up but not 100% to special education, approximately 75% and that the base per pupil funding for public schools went from \$9,150 to \$9,608 per student a 9% increase. Michelle announced that she has become the new Chairperson for the Arc Education Committee and announced that Debbie Whitford would be assuming the role of recording the meeting minutes.

Kenya Harper discussed that she, Victoria Martinez and Kanika Littleton will no longer be eligible to serve on SEAC and that the new representatives will be: Chris Somerville, Kelsey Biswanger, Stephanie Nicholls and Margarita Rodriguez-Curry. Members discussed a possible day change for Arc Education Committee from Wednesdays to Thursdays to accommodate SEAC attendees. Members discussed sending out a poll on the best day but felt Thursday at 10AM may be the best fit.
