- Issue the Choice Voucher Technical Advisory & Fiscal Issue the Choice Voucher Technical Advisory & Fiscal Intermediary guidance
- Examine the elements from the Standards Group that address individual budget development quidance
- Consider recommendations compared to CMS requirements for selfdirected services per most current version of the 1915 (c) directed services Waiver technical guide
- Survey CMHSPs on current activity to implement the SD on current policy, including needs for assistance
- Convene a reference group to assist with providing guidance and assistance to address survey findings
- Develop and pilot test site review criteria
- Movement to compliance with the policy and with technical advisory quidance
- Must include significant feedback from participants in arrangements supporting selfdetermination

systems change at the state and local agency levels.

In 1997, Mike led Michigan's Self-Determination Initiative funded through the Robert

Wood Johnson Foundation. As an option supporting consumer/family control over services for persons with

developmental disabilities, Michigan's Self-Determination Initiative built a foundation for major system change which assures that services and supports for people are not only person-centered, but person-defined and person-

controlled.

This effort culminated in the 2004 adoption of a system-wide requirement supporting consumer access to arrangements that support



self-determination as a matter of state policy in the Michigan community mental health system.
