## Governmental Affairs/Legislative update:

Emily Henderson, Governmental Affairs Consultant and Lobbyist for Arc Michigan with McCall Hamilton, joined us for this meeting to share a governmental affairs/legislative update.

Emily gave a recap of what this fall will look like. The legislature could adjourn before Halloween so the presidential primary can be held in February. Waiting for outcomes of November elections for 2 house democrats running for mayoral seats to see what legislature will look like.

Big priorities are family paid leave, energy and climate solutions, reproductive health, and Medicare drug prices.

Emily is continuing to follow these bills and will keep the committee updated on status:

Guidance counselors to address support in schools and the decline in high school graduates going to college (not specifically mental health counselors)

- **OSE Updates** (Jessica Brady, OSE Performance Reporting Unit)
- MARSE 2023 Rule Revisions to R 340.1721b, R 340.1723, and R 340 1733
  - Overview of proposed rule changes that OSE is working on
  - To align with the IDEA requirements the determination of eligibility and the provision of FAPE for students who are parentally placed in private schools.
  - To align with the IDEA requirements for an Independent Educational Evaluation (IEE) and addresses requirements for districts regarding IEEs.
  - Addressing age span for special education programs operated in elementary buildings to not exceed at any one time, a 6-year age span or the age span of students who are non-disabled in the building, whichever is less. Challenging for districts who choose to operate young 5's, preschool programs, or other early childhood programs within the elementary building.
- SEAC and Person-First Language vs. Identity-First Language
  - Depends on the community or person being discussed. Language used should be selected based on person's expressed preference.

#### Committee work:

We continued reviewing and revising **Universal Design for Learning**, **Pathway to Kindergarten**, and **Schoolwide Positive Behavior Interventions and Supports** Position Statements.
