#### **Governmental Affairs/Legislative Update:**

Emily Henderson, Governmental Affairs Consultant and Lobbyist for Arc Michigan with McCall Hamilton.

General overview House/senate taking steps to negotiate. Took all budgets and sent to floors. Over the next week bills will go to opposite chambers and items sent to conference committees for discussion. Budget timeline is to pass budget by second week of June. No public committees, just stakeholders and legislators. May will update revenues in budget for review and attempt to get done by summer break. Target for budgets to be finalized document by July.

The Senate didn't move to full funding of preschool. Increased special education funding. Discussion on lack of continuing education, per pupil allowance.

School safety bills- a meeting with Representative Kelly Breen is scheduled for May 6<sup>th</sup> to discuss concerns and provide recommendations for bill language discussed by the education committee She may say that another bill would need to be introduced

Darlene asked about budget recommendations. The House recommended 2.6 billion, Senate recommended 2.7 billion, the same as the Governor. 376 million increase for special education. Darlene asked about where the money was going from the MI lottery. Emily stated that the state gets revenue reports. All of MI lottery profits go into the State School Aid Fund. School. School Aid Fund gets the same amount as other 10 state budget areas. Per pupil language should be the same-only money line will change.

Discussed "boilerplate" - the specific language of the appropriation bill or public act that provides information about the intent and which direct, limit, or restrict lineitem expenditures.

Emily will be out of the country for a vacation. Whitney will be the contract if the Education Committee has any questions this month.
