Expecting legislative schedule to be more clear post-election on November 5

House and Senate were both in on September 25 to move bills to the other chamber and Gov's desk. Notable items include:

- Senate Bills 567 and 568, legislation to require prescreening for dyslexia in public schools. The bills now head to the desk of Governor Gretchen Whitmer.
- House Bill 5503, a supplemental appropriations bills to provide a per-pupil mental health and school safety grant and the creation of a school safety tip line
- Mouse Bill 5803, a bill to make changes to the Michigan Public School Employee Retirement System (MPSERS) that would eliminate a requirement that members, who became a member before September 2012, contribute 3% of their compensation towards the retiree health care benefits, as well as requiring the contribution rate applied to payroll not exceed 15.21%.

Revisions to the Michigan Administrative Rules for Special Education became effective on June 27, 2024. The document Michigan Administrative Rules for Special Education (MARSE) With Related Federal Regulations has been updated to reflect the changes to the following rules:

- R 340.1721b: Makes the process for determining eligibility for special education for parentally placed students in nonpublic schools is consistent with 34 CFR §§300.130 to 300.147.
- R 340.1723c: Removes the requirement for a parent's request for an Independent Education Evaluation to be in writing consistent with 34 CFR §300.502.
- R 340.1733: Modifies language to require the age span for students who are assigned special education programs, except for severe cognitive impairment and serve multiple impairments operate in an elementary building so age span does not exceed the age span of students who are nondisabled in the building.
